


WELCOME, HUSTLER



COVID-19 POLICY

Industry Dance Co. takes no responsibility for any actions relating to the COVID-19 pandemic. In the event of a forced shutdown or interruption of classes, we will transition all remaining classes in the session to a virtual platform. No refunds will be provided as all services will continue online.

Should you have to miss your scheduled class, please contact the studio at inquiries@industrydanceco.ca If you have any COVID-19 like symptoms, we kindly ask that you please stay home and notify the studio of your absence. Should you still want to participate in your scheduled class, we will send a link so you're able to join in virtually.

DRESS CODE + FOOTWEAR

Ensuring your child is dressed appropriately for their specific class is incredibly important, as dancers must be able to move comfortably without feeling restricted or limited due to their attire. Wearing the proper and appropriate attire for class also allows instructors and teachers to see the dancers posture and alignments.

To prevent lost items, we kindly ask parents and guardians to please label your child's shoes. All students should also be aware of good grooming and hygiene. Please ensure your pre-teen and teenage children use a good anti-perspirant or deodorant as they will be sweating in class. Please remind children to always wash their hands before returning to class after using the washroom.

LOST AND FOUND

A lost and found bin is located at the front desk. If your child is missing dance wear, shoes, or any other personal belongings, please feel free to contact the front desk to check the lost and found. Items left in the student lounge and classroom are added to the bin at the end of each night. At the end of each month, the lost and found will be emptied and donated to charity.





ATTENDANCE POLICY

Students should not attend class if experiencing any of the following: a fever, nausea / vomiting, diarrhea, difficulty breathing, infected skin or eyes or suspected communicable disease or lice, or have any of the symptoms of COVID-19 (cold or flu-like symptoms, such as a cough, fever, runny nose, sore throat, headache, or any of the symptoms listed in the screening tool to self-isolate for 14 days).

Should a student have to miss their scheduled class, please notify the studio via phone or email at your earliest convenience. Please note – refunds are not issued for missed classes (i.e. illness, vacation or other.) In the event of the studio needing to cancel class(es) due to instructor illness (when a replacement cannot be found) classes will be re-scheduled. In the event of the studio needing to cancel class(es) due to inclement weather, power outage or any other unforeseen circumstances classes will not be rescheduled and are non-refundable. Students may make up missed classes in an alternate class of the same level by scheduling a make up class with the studio administrator.

SHOW OFF WEEK

"Show Off Week" is a seasonal event Industry Dance Co. hosts each session, where parents and guardians are invited into class to sit, observe and experience the magic of their child's dance classes. This fun and exciting week is an awesome time for parents to take pictures, videos and witness all of the growth their child has made throughout the session. For some children, "Show Off Week" may their first time performing in-front of a live audience, so we encourage at least one parent/guardian to be in attendance to watch and cheer on their dancer.

Although "Show Off Week" is about showcasing all of the skills dancers have learned throughout the session, we do remind parents/guardians that "Show Off Week" is still a class and remind everyone to do their best to not distract dancers throughout the class. Our goal for "Show Off Week" is to provide parents/guardians with an authentic, #SickerThanYourAverage experience where they can sit back, relax, and enjoy watching what their child has been learning!

STUDIO RULES

In order to create a safe and welcoming classroom atmosphere most conductive for learning, Industry Dance Co. has the following policies and guidelines in place:

- 1 Students are advised to arrive 10 minutes prior to the start of their class and are to be picked up no later than 10 minutes after the end of their class.
- 2 All preschool students must be supervised by their parent/guardian befor class. We ask that parents/guardians stay nearby and/or wait in our lobby for the duration of the class. Industry Dance Co. instructors and staff are not responsible for students before or after class.
- 3 Only dancers, Industry Dance Co. staff and instructors are allowed inside of the classroom. Industry Dance Co. does not spectators, including parents/guardians, siblings or friends to sit in during the class.
- 4 No food or drinks are permitted in the classroom, other than bottled water. Gum chewing is not permitted in any class.
- 5 Students may bring a small bag into the studio with them for their belongings, however, all belongings should be kept in the back of the studio in our student lounge, as personal belongings are not permitted in the classroom. This includes all backpacks/dance bags, coats/jackets, sweaters, outside shoes, etc.
- 6 Cellphones and recording devices are not permitted in the classroom.
- 7 All students must arrive dressed appropriately for their scheduled class and in accordance to Industry Dance Co.'s dress code. All students must have the proper dance attire and footwear in order to participate in their regular scheduled class(es) as failure to meet dress code will result in a loss of class.



STUDIO RULES

- 8 Running in and around the studio will not be tolerated as this is a safety issue. Students are encouraged to use their "walking feet" to avoid running into others, tripping or slipping and falling.
- 9 Students are not to exit the classroom without permission from their instructor.
- All students must practice our "hands-off" policy, keeping hands to themselves at all times, respecting others space and studio property.
- In order to participate in class, students must be respectful of their teachers. Should a student have a question, they are encouraged to raise their hand and wait patiently until their instructor gets to them. Being disruptive, talking back and behaving poorly is not acceptable and will not be tolerated. In the event of continuous poor behaviour the instructor may ask the student to sit out.
- 12 Industry Dance Co. has strict bully-free environment that is strongly enforced. Bullying, teasing, poking fun at and/or taunting of any kind will not be tolerated whatsoever. All students are to treat everyone with respect at all times.
- 13 When class has begun, please refrain from entering the classroom. Should you need to communicate with your child or your child's instructor, please visit the front desk for assistance.



COMMUNICATIONS

Industry Dance Co. communicates with all parents/guardians predominantly by electronic mail. By providing your email address at the time of registration, Industry Dance Co. has been granted consent to send news, announcements, and any pertinent information via email. Email is Industry Dance Co.'s primary source of communication and in the event of a class cancellation, closed business day, important update, etc. all communications will be sent via email.
